

PRIVACY POLICY OF FPM INVEST N.V.

FPV Invest N.V., registration No. 151833, registered address is at Heelsumstraat 51, Curacao; is the Operator of the Website www.cryptofairplay.com.

FPM Invest N.V. is referred to as “cryptofairplay.com”, “We”, “Us”, “Our”, “Management”, “Site”, “Operator” or “Company”.

The Player and registered Account Holder shall be referred to as “You”, “Yours”, “Customer” or “The Player”.

KEY DEFINITIONS

“**Privacy Policy**” means the Operator’s privacy policy accessed via the Privacy Policy link on the Website, which is an integral part of the Terms of Use;

“**Rules**” means the Game Rules specifically applicable to the relevant type of gaming;

“**Services**” means, as appropriate, the services offered for the time being by the Operator through the Website and/or via any Access Device application;

“**Website**” means the website or any respective page, subpage, subdomain or section thereof from time to time, located at or accessible via the domain name: www.cryptofairplay.com.

1. GENERAL TERMS

1.1 By using and/or visiting any section of the Website, or by opening an account with the Operator through the Website, You agree to be bound by the Privacy Policy and You accordingly: (a) agree to the use of electronic communications in order to enter into contracts; and (b) waive any applicable rights or requirements which require a signature by hand, to the extent permitted by any applicable law; (c) agree, that in order to use Our Service You are requested to provide Us with certain personal information which shall be processed on the basis of our Privacy Policy.

1.2 The original text of the Privacy Policy is in English and any interpretation of them will be based on the original English text. If the Privacy Policy or any documents or notices related to them are translated into any other language, the original English version will prevail.

1.3 Please read the Privacy Policy carefully before accepting them. Once You have accepted the Privacy Policy, please print the Privacy Policy and store them, along with all confirmation emails, additional terms, transaction data, game rules, fair deal rules and payment methods relevant to Your use of the Website. Please note that the Privacy Policy is subject to change, as set out in clause 1.5 below.

1.4 If You do not agree to accept and be bound by the Privacy Policy please do not open an account, and/or continue to use Your Account. Your continued use of any of the Services will constitute acceptance of the Privacy Policy which we have notified You are in force from time to time.

1.5 We may need to change the Privacy Policy from time to time for a number of reasons, including (without limitation) to comply with law or regulations, to comply with instructions, guidance or recommendations from a regulatory body, or for customer service reasons. The most up-to-date Privacy Policy can be accessed from the Privacy Policy link in the footer section of the Website.

Where We make changes to the Privacy Policy which we wish to notify You of, we will do so by such method of notification as We may, in our discretion, deem appropriate.

1.6. We are a Data Controller of your information.

We take data privacy very seriously and we are committed to protecting and respecting the rights of all individuals. We are dedicated to ensuring the confidentiality and privacy of information entrusted to Us and aspire to be transparent when We collect and use personal data.

1.7 The Operator's legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information We collect and the specific context in which We collect the information:

- We need to perform a contract with you,
- You have given Us a permission to do so,
- Processing your personal information is in Our legitimate interests,
- We need to comply with the law.

1.8 We will retain your personal information only for as long as it is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

1.9 If you wish to be informed what Personal Information we hold about you and if you want it to be removed from our systems, please contact us at support@cryptofairplay.com.

2. PERSONAL INFORMATION

2.1 The kinds of Personal Information that We may collect from you is:

- Full name,
- Date of Birth,
- Email address,
- Personally submitted preferences,
- Location data,
- Country of residence,
- IP address,
- Other verification information such as your betting activities.

2.2 To verify your age we may collect from you the following documents:

Passport,
Driving license,
National ID Card.

3. COLLECTION PURPOSES

3.1 We will collect your Personal Information only by lawful and fair means and not in an intrusive way to operate its business for the following purposes:

- If you wish to subscribe to Our weekly newsletter.
- To process Your application to become a Customer of FPM Invest N.V.
- To provide services to you as the Player.
- To identify You as the Player for security purposes and to comply with Our legal obligations.
- To maintain Your account.
- To upgrade and enhance Your experience within the Website or over the telephone, or to tailor or develop information, services or products to suit Your needs which may include market research and conducting promotions.
- To tell You about Our products or services that We think may be of interest to You by communicating with You via email, SMS or telephone.
- To create aggregate data about Customers through demographic profiling, statistical analysis of the database to provide to potential and existing stakeholders, and to allow for more efficient operation of Our business.
- To determine Your liability to pay goods and services tax and other taxes where applicable.
- To comply with Our legal and statutory obligations.
- For taking appropriate action if We have reason to suspect that unlawful activity or misconduct of a serious nature has been, is being or may be engaged in that relates to Our functions and activities.
- To establish, exercise or defend any legal claims.

3.2 If You do not provide Us with the Personal Information We request, We may be unable to process Your application to become a Customer, provide You with Our Services or respond to Your enquiry or complaint.

3.3 By becoming a Customer or otherwise choosing to provide Us with Personal Information You consent to US collecting, using and disclosing Your Personal Information for the above purposes.

4. YOUR RIGHTS

4.1 In certain circumstances, you have the following data protection rights:

- The right to access the information we have on you.
- The right of rectification.
- The right to erasure.
- The right of restriction.
- The right to object.
- The right to data portability
- The right to withdraw consent

4.1.1 Your right of access – You have the right to ask us for copies of your personal information. This right always applies. There are some exemptions, which means you may not always receive all the information we process.

4.1.2 Your right to rectification – You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete. This right always applies.

4.1.3 Your right to erasure – You have the right to ask us to erase your personal information in certain circumstances.

4.1.4 Your right to restriction of processing – You have the right to ask us to restrict the processing of your information in certain circumstances.

4.1.5 Your right to object to processing – You have the right to object to processing if we are using legitimate interests as our lawful basis for processing.

4.1.6 Your right to data portability – This only applies to information you have given us. You have the right to ask that we transfer the information you gave us from one organisation to another, or give it to you. The right only applies if we are processing information based on your consent or as part of a contract, or in talks about entering into a contract and the processing is automated.

4.1.7 Your right to withdraw consent – You can withdraw your consent that you have previously given to one or more specified purposes to process your personal data. This will not affect the lawfulness of any processing carried out before you withdraw your consent. It may mean we are not able to provide certain products or services to you and we will advise you if this is the case.

5. DIRECT MARKETING AND OPTING OUT

5.1 If You gave Us a consent to use Your Personal Information for the direct marketing purposes, We may from time to time use Your Personal Information to inform You about Our products or services or about promotional activities which We believe may be of interest or of benefit to You. We may do this via email. If You no longer wish to receive marketing or promotional material from the Operator at all or in any particular form, You may contact Us at any time by email to **support@cryptofairplay.com** with your request with which we will comply as soon as is practical.

5.2 From time to time We may contact You in relation to the management and administration of Your account. These communications can be via any of the modes of contact recorded when registering as the Player. Such communication does not affect Your opt-in or opt-out status for direct marketing communications.

6. MANAGEMENT OF YOUR PERSONAL INFORMATION

6.1 We will take all reasonable steps to ensure that the Personal Information which it collects, uses or discloses is correct and is stored in a secure environment which is accessed only by authorized persons.

6.2 We will destroy or permanently de-identify the Personal Information we hold when it is no longer required for any purpose permitted under the Terms of Use, including our legal or operational obligations.

7. SECURITY OF PERSONAL INFORMATION

7.1 FPM Invest N.V. is dedicated to keeping Your data safe. We have technical and organisational policies and procedures in place to protect personal data from loss, misuse, alteration or destruction.

7.2 You acknowledge that no data transmission over the Internet is totally secure. Accordingly, We do not warrant the security of any information which You transmit to it. Any information which You transmit to Us is transmitted at Your own risk.

7.3 We will take reasonable steps to protect Your Personal Information from misuse, loss and unauthorised access, modification and disclosure including by using password protected systems and databases and Secure Socket Layer (SSL) technology.

7.4 We ensure that access to Your Personal Information is limited only to those who need to access it and those individuals are required to maintain the confidentiality of such information. Where necessary, We apply encryption and anonymisation techniques in efforts to further protect personal data.

7.5 Our employees, agents and contractors are required to maintain the confidentiality of Player' Personal Information and trading behaviour.

7.6 Information posted on bulletin boards or communicated within a social media environment (for example, Facebook, Twitter, Chat Rooms) becomes public information. We cannot guarantee the security of this type of disclosed information.

7.7 Ultimately, You are solely responsible for maintaining the secrecy of your username, password and any account information. Please be careful whenever using the Internet and Our Website.

8. ACCESS TO PERSONAL INFORMATION

8.1 You may access the Personal Information collected by the Operator by following the “Settings” link on the website or by contacting us on support@cryptofairplay.com.

8.2 We will give you access to Your Personal Information in the manner requested if that is possible and within a reasonable period.

8.3 If we refuse your request or cannot give You access in the manner You have requested, We will do what We can to meet your requirements by other means. We may not be required to give you access to your Personal Information in certain circumstances, where it may have an unreasonable impact on other individual's privacy. If we refuse access for such reasons, We will advise you in writing of the refusal and Our reasons and the complaint mechanisms available to You.

9. LOG FILES

9.1 FPM Invest N.V. follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable.

9.2 The purpose of the information is for analyzing trends, administering the Website, tracking users' movement on the Website, and gathering demographic information.

10. PRIVACY POLICIES

10.1 You may consult this list to find the Privacy Policy for each of the advertising partners of FPM Invest N.V.

10.2 Third-party ad servers or ad networks uses technologies like cookies, JavaScript, or Web Beacons that are used in their respective advertisements and links that appear on the website, which are sent directly to users' browser. They automatically receive your IP address when this occurs. These technologies are used to measure the effectiveness of their advertising campaigns and/or to personalize the advertising content that you see on websites that you visit.

13.1 Our Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect in FPM Invest N.V. This policy is not applicable to any information collected offline or via channels other than this website.
